- Deadline for Supplemental or Escape Assessments are 60 days, either from the date of notice or the bill depending on the county.
- Supplemental Bills or Notices are sent out due to a change in ownership or New Construction.
- Escape Bills or Notices are typically sent out due to business personal property audits.
- If you miss the 60-day window, you can file for an appeal during the normal filing time frame from July 1 to either September 15 or November 30, depending on the county. Except for business personal property audits.
